**11.1 Information on toxicological effects**

**Acute toxicity** May be harmful. This product is used in veterinary applications. Use safe work practices to avoid eye contact, prolonged skin contact and ingestion. Refer to medical doctor/specialist for advice regarding adverse side effects.

**Skin** Not classified as a skin irritant. Contact may cause temporary mild skin irritation.

**Eye** Not classified as an eye irritant. Contact may cause mild irritation and lacrimation.

**Sensitisation** Not classified as causing respiratory sensitisation. Some evidence suggests albendazole is a possible skin sensitiser.

**Mutagenicity** Not classified as a mutagen. Some studies have shown albendazole is an in vivo somatic cell mutagen and probably acts as an aneuploidogen. However, aneuploidogens are considered to have a threshold exposure below that which will not represent a risk to humans or animals.

**Carcinogenicity** Not classified as a carcinogen.

**Reproductive** There is sufficient data to indicate that albendazole may damage fertility or the unborn child.

**STOT - single exposure** Symptoms of levamisole toxicity mimic organophosphate toxicity (salivation, lacrimation, urination and defecation, hyperesthesia, seizures and irritability). Acute over exposure to levamisole has been reported to cause agranulocytosis (depletion of the white blood cells). Symptoms of agranulocytosis include sore throat, persistent or recurrent fever, swollen glands and skin infections.

**STOT - repeated exposure** Not classified as causing organ damage from repeated exposure.

**Aspiration** Not classified as causing aspiration.

**Additional information** **WORKPLACE CONTROLS AND PRACTICES:** Unless a less toxic chemical can be substituted for a hazardous substance, **ENGINEERING CONTROLS** are the most effective way of reducing exposure. The best protection is to enclose operations and/or provide local exhaust ventilation at the site of chemical release. Isolating operations can also reduce exposure. Using respirators or protective equipment is less effective than the controls mentioned above, but is sometimes necessary.

RESPIRATORS: In general the use of respirators should be limited and engineering controls employed to avoid exposure.
